<b>Background information</b>	Trinity Metals is registered in the British Virgin Islands and has three Opcos in Rwanda following the merger transaction involving all the shareholders of the three Opcos. We are now exploring the opportunity of establishing Trinity locally. To be able to do so, we would require to conduct a thorough legal and tax analysis to ensure that we provide the Board with necessary information to make informed decision on whether it serves the company's interests to register locally and if so, understand the adverse this may have to our operation companies. We have extended the scope to cover the transactions that birthed Trinity and the legal and tax implications this would have to the operational companies.
