Reference is made to the amendment of tax law in Rwanda (LAW N° 009/2025 OF 27/05/2025 AMENDING LAW N° 049/2023 OF 05/09/2023 ESTABLISHING VALUE ADDED TAX)

Article 8 of Law n° 049/2023 of 05/09/2023 establishing value added tax amended and removed trucks (Fuso and Howo) from the list of VAT Exemptions.

Reference is also made to the letter received from FUSO owner (Twagiramungu) dated 24th October 2025 requesting Rutongo Mines Ltd to add VAT on the rental amount paid per month from 1,400,000Rwf to 1,652,000Rwf per Month VAT Inclusive) and

Reference is made to the letter received from HOWO owner Ntahompagaze Innocent dated 25th August 2025 requesting Rutongo Mines Ltd to add VAT on the rental amount paid per month from 4,500,000Rwf to 5,310,000Rwf per Month VAT Inclusive

This internal memo approves the addition of VAT on the rented vehicles (FUSO and HOWO).

All other terms and conditions regarding rented vehicles (FUSO and HOWO) remain unchanged.
