Dear Sir,

As highlighted, there is a significant ongoing demand for timbers across all the sites. The previous batch of trees was utilized to address the first phase of critical underground support issues. However, several outstanding and pending works remain, alongside continuous requirements for timber, particularly planks for box construction, handrail installations, and general ground support across the mine.

The total cost of the current requirement appears substantial if executed within a single month. To ensure financial manageability while still addressing operational and safety needs, the order has been strategically distributed over a three-month period. This approach results in an estimated monthly expenditure of RWF 17.5 million. Given that our current stock levels are critically low, your review and approval are kindly requested to proceed with this order to avoid disruptions to ongoing operations and to maintain safe working conditions underground.

Your guidance and approval will be highly appreciated.
